Entrants are to include, with their application, a CD or MP3 of their proposed performance. Submission of an Application Form with payment does not guarantee progression to the heats of Crestwood Idol 2010. Entry is subject to acceptance of act based on submitted tape, CD or MP3. Total performance must not exceed 5 minutes duration. Successful heat entrants will be notified two weeks prior to the heat after the panels' review of CD or MP3. Performers under the age of 18 must be accompanied by an adult at all events and venues. Crestwood Idol 2010 cannot and will not accept explicit language, inappropriate dress and/or behaviour being part of any performance. All performers are responsible for providing their backing music. Entrants are to provide two copies of backing music, CD only, on the day of performance. All Copyright issues must be complied with and are the responsibility of the entrant. The quality of CD is to be of a high standard, clearly labelled with the performers name and CD track number prior to arrival at performance. All production, at the heats and final, will be supplied in-house. The organisers will provide appropriate sound technicians and stage crew.
